He also advised the Governing Board that there are no changes to the CMP Communications Contract that is up for renewal in the Consent Agenda. Lastly, he provided clarification on the position change and salary adjustment of an employee from Fiscal Payroll Specialist to Fiscal Services Officer and that he is working on plans for filling the now vacant payroll specialist position.

### **Superintendent's Report**

Dr. Mengerink complimented the Finance and HR departments on their management of the complex EANS program. He also shared the struggles that many districts are currently facing with bus driver shortages and the ESCs interaction with the Cuyahoga County Emergency Management Agency to find solutions, which may include the National Guard, if decided upon by the Governor. In addition, he highlighted support that Russ Bennett has been providing for the Acting Superintendent in Streetsboro while the Superintendent is on medical leave and his upcoming work with Shaker Schools in helping to manage the implementation of multiple components of PowerSchool's software.

Dr. Krol mentioned an OSBA email inviting school board members to a virtual conversation tonight with Governor DeWine and Pediatric Health Experts about the current increase of COVID-19 cases in children. Dr. Krol also discussed attending the OSBA webinar, Drafting and Implementing District Equity Policies. This webinar included presenters from Shaker Heights and Cincinnati Schools, OSBA, and a consultant in diverse at-risk learners. Speakers said equality and equity are not the same. Educational equity means student demographics shouldn't predict achievement and it focuses on opportunity gaps. Non-discrimination policies are passive and not enough, but equity policies are pro-active and hopefully lead to equality. Equity policies should be unique to districts' needs and include a metric to assess where inequities lie. Equity Policies were shared.
