Board Member Reports and Comments

Mrs. Fortlage reported on the Finance and Technology Committees and mentioned the new ESC website.

Mr. Hocevar did not have a report but affirmed the Facilities Committee discussion and items in flux.

Dr. Krol reported on the Curriculum Committee meeting. This included information from Shelly Gaski about the multiple topics on which districts are seeking support from the curriculum department, as well as information about the Equity Audits. She mentioned that Russ gave an update on the PLCs and Instructional Technology services. In addition, Nadine noted that the ESC was continuing the Disrupting Poverty series, career awareness and readiness efforts in CMSD, and several workforce development initiatives. She also shared that Michele Shrefler provided an update on OTES/OPES trainings, which are hybrid with a majority of people attending virtually. In addition, she referenced a USDOE grant of \$14.5 million that, if funded, would be used to increase the recruitment and retention of teachers of color in four partner districts. Lastly, Dr. Krol stated that she attended the virtual PEP Rally with Dr. Bruce Perry.

Mr. Mahnic reported on some controversy faced by the Cuyahoga Heights Board about changing the school mascot name. He also mentioned that he attended the Technology Committee and that he always looks forward to these meetings. Lastly, he mentioned his attendance at the Facilities Committee and added the fact that we will eventually need a new roof on the Essex Building.

Mr. Miceli reported on the Curriculum Committee. He talked about the Building and Industry Leadership Teams (BILT) that Paula and a team are facilitating as a part of the Business Advisory Council. He also praised Paula's introduction about the ESC during the BILT meeting that he attended virtually. He referenced the Administrative Academy that was held by the ESC and noted that Steve Rogaski identified a shortage of intervention specialists while gearing up our educational programs.
