### Ann Slone, M.A., CCC-SLP

Ann Slone is a retired supervisor from Hamilton County ESC. She has served local, state and national professional committees and organizations. She was a manager/author of the OMNIE Guidelines. Ann has presented at local, state and national conferences on topics such as workload, RtI and collaboration between school/hospital SLPs.

**Course Description:** Ann Slone will share and discuss common scenarios that require both understanding of the legal aspects of special education as well as an awareness of professional ethics.

**Learning Objectives:** Participants will:

1. Acquire the 2 hour Ethics Training required by the Ohio Board of Speech and Hearing Professionals Board for license renewal (December, 2018).
2. Discuss common scenarios in special education around provision of FAPE, LRE, social media, workload, compliance, etc.



### Dr. Chuck Carlin

Dr. Carlin is an associate professor at The University of Akron. In addition to teaching in the School of Speech-Language Pathology and Audiology, he was the primary investigator on the Caseload Ratio Study. He created resources on the workload approach for the Ohio Department of Education and Ohio Master's Network Initiatives in Education (OMNIE). He teaches courses in literacy, school-based speech-language pathology services, developmental disabilities, and neurogenic communication disorders. Before coming to the University, he worked as a school-based SLP, speech-language supervisor, and special education supervisor.

**Course Description:** In Ohio, educational agencies utilize a data-driven process to determine service providers' workload and caseload size. This session will overview the requirements from the Operating Standards from the perspective of a speech-language pathologist (SLP). Participants will learn about various resources that can be used to calculate an appropriate workload. They will also learn about strategies that other Ohio school districts are using to manage their SLPs' workload.

2. Describe the major components of Ohio's workload approach
3. Explain strategies to manage workload
