



Kindergarten Readiness Assessment

(KRA) Refresher

August 10, September 6, or October 3, 2016

9:00 a.m.—12:00 p.m., Sign-in begins 8:30 a.m.

This half-day training is not required. This training is only open to individuals who successfully completed the KRA training in a previous year, but who wish to engage with learners in a refresher course related to the KRA.

(KRA) Hybrid

August 19, September 1, September 8, or October 6, 2016

9:00 a.m.—4:30 p.m., Sign-in begins 8:30 a.m.

This required training is for Kindergarten teachers who have never been trained on the KRA but will be administering during the 2016-2017 school year. In this hybrid format, teachers will attend professional development for one day and then complete online assignments and the content/simulator assessments after leaving the professional development. Teachers attending the full PD and receiving passing scores on both assessment will be deemed reliable assessors for the KRA and receive certificates. Technical assistance is available for those that need additional support.

(KRA) Two-Day

September 28 & 29, 2016

9:00 a.m.—4:30 p.m., Sign-in begins 8:30 a.m.

This required two-day training is for Kindergarten teachers who have never been trained on the KRA but will be administering during the 2016-2017 school year. In this face to face format, teachers will attend professional development for two day and then complete content and simulator assessments during the PD. Teachers attending the full PD and receiving passing scores on both assessment will be deemed reliable assessors for the KRA and receive certificates. Technical assistance is available for those that need additional support.
